Vendors are responsible for bringing their own tables, chairs, and staging items. Electrical outlets are limited so plan accordingly or contact us beforehand.

Vendors & all employees must wear provided name badge at all times.

Vendors are required to have their booth open for the duration of the show. Any signs of vendor packing can make the remaining customers uneasy and tends to end any last minute shopping. If you do so, you will not be allowed to participate at future shows.

Please be at your booth at all times, you will not be allowed to take down your booth early unless special permission is acquired.

Vendors are responsible for their own booth set-up.

Vendors will be able to restock and reorganize their booth an hour early on Friday and Saturday

Please submit 3-4 pictures of your items or booth set up from previous shows

Vendors are responsible for calculating and reporting all applicable sales tax on vendor's merchandise

Vendor grants permission to promoter to use images of Vendor booths and items for any purpose in connection with the promoting the event. The promoter may crop or modify such images, text and graphics without notifying the vendor. Vendor grants the promoter to use his/her names and any other information in order to promote the event.
